This trial is limited to **330 runs per day, per Judge**. Total of 660 runs per day. Entries will be accepted on a "First Received" basis. Entries **OPEN** 9 am, Monday, August 17, 2009

A maximum of ten entries per envelope is allowed. Envelope/transactions with more than ten dog maximum will be returned as an invalid entry.

AWARDS

First through Fourth place rosettes will be awarded in each class for each height division for qualifying scores. Qualifying ribbons will be awarded to all dogs receiving qualifying scores.

Valle Del Sol Golden Retriever Club will be awarding special pins for **Double Qualification** in Standard and JWW from the Excellent B class.

Titling rosette is offered to dogs finishing an Agility title(s) at these trials.

ELIGIBILITY OF DOGS

All dogs fifteen (15) months of age or older that are registered with the American Kennel Club are eligible to participate. Dogs of an AKC registerable breed that have been granted an Indefinite Listing Privilege (ILP) number may participate (refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate).

Dogs of a registerable breed with an acceptable foreign registration number are eligible to participate subject to Chapter 11, Section 1 of the Dog Show Rules.

Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible. Bitches in season shall not be eligible to participate.

HEIGHT DIVISIONS

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any Trial. At the handler's option, dogs may be entered in a higher height division in regular classes, but not in a division lower than their proper height division. Dogs running in Preferred classes must run at the proper height. Dogs that enter in a height division lower than their proper division will be moved up. In no case may a dog be moved down in height based on a judge's measurement at a trial. The following jump height divisions shall be used in all trial classes:

Regular	Preferred*	
8"	4"	For dogs 11 inches and under at the withers
12"	8"	For dogs 14 inches and under at the withers
16"	12"	For dogs 18 inches and under at the withers
20"	16"	For dogs 22 inches and under at the withers
24" or 26"	20"	For dogs over 22 inches at the withers

FAST CLASS

Fifteen And Send Time (FAST) Class

This agility titling class is meant to be an additional test of strategy skill, accuracy and speed with timing and distance handling. It demonstrates a dog's athletic ability and willingness to work with its handler in a fast-paced atmosphere over a variety of agility obstacles.

The Fifteen and Send Time Class uses fifteen (15) point valued obstacles and/or obstacle combinations. The course will include a 'Send Bonus' with distance challenge that will award earn a bonus of twenty (20) points if completed successfully. Teams must successfully complete the Send Bonus to achieve a qualifying score, as well as a minimum number of required points defined at each class level.

Level	Minimum score to Qualify	Distance for Send Bonus
Novice	50 points	5 – 10 feet
Open	55 points	10 – 15 feet
Excellent	60 points	15 – 20 feet

The handler picks the order in which the obstacles are taken (there are no wrong course penalties). Team will use the following Standard Course Time (SCT) to accumulate points, attempt a Send Bonus and to reach the finish line. Each second over the SCT is a one point penalty.

Regular	SCT
8"	38 seconds
12" / 16"	35 seconds
20" / 24" / 26"	32 seconds

Preferred*	SCT
4"	41 seconds
8" / 12"	38 seconds
16" / 20"	35 seconds

The FAST class is not part of the Master Agility Championship titling program.

OBSTACLES

Obstacles will conform to current requirements of the Agility Rules and Regulations.

MOVE-UPS

Trial Secretary must receive move-up form by 6:00 PM the Monday, 10/19/09. There will be day-to-day move-ups Saturday to Sunday provided the request is made in writing to the Trial Secretary on Saturday at the trial.

RING INFORMATION

This trial will be held in 2 rings, 100 feet by 100 feet in diameter. It will be held outside on grass, regardless of weather.

SET-UPS

You can set up Friday afternoon. Limited shade is available.

Overnight security will be provided both Friday and Saturday night. However dogs, equipment or personal items left on Show Grounds are the responsibility of each exhibitor. Valle Del Sol Golden Retriever Club is not responsible for lost or stolen dogs or equipment.

EXHIBITOR INFORMATION

The trial will be conducted under American Kennel Club **Regulations for Agility Trials**. For copies of the Regulations, write to The American Kennel Club, 5580 Centerview Dr Suite 200, Raleigh NC 27606 or call (919) 854-0199. Also can be printed directly from the AKC website www.akc.org

Entries must reach the Trial Secretary by 4:00 pm of the closing date or before an entry limit of 330 per day per judge has been reached. Fees must accompany entries. Express-mailed entries **MUST** include signature permitting them to be left at the Event Secretary's address without recipient signature. Exhibitors are responsible for complete, accurate and legible information on their entry forms.

Entry fees are non-refundable except for bitches coming into season after the closing date will be eligible for a refund up to 75% of total entry fee paid. If, because of weather, riots, civil disturbance or other acts beyond the control of the club, it is impossible to open or complete the show, no entry fees will be refunded.

Exhibitors are responsible for the behavior of their dogs and/or children. There will be no refund of entry fee for exhibitors that are asked to leave the show site because of their dog or children creating unnecessary disturbances or repeatedly engaging in unsafe behavior.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Arizona requires rabies vaccine every 3 years.

Official AKC Measuring for Jump Height Cards will be offered at the Saturday and Sunday trials. Effective 9/1/2006, two measurements at the same jump height are required to obtain a permanent official AKC Jump Height card after the dog turns two years old.

The safety of the dog is our primary concern. Any exhibitor entering this trial acknowledges that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all of the obstacles safely.

All dogs must be on leash at all times while on the show premises except when in exercise pen, at practice jump or in agility ring.

Do not leave any dogs in closed vehicles. All persons attending this dog show hereby waive any claim for damages against the Valle Del Sol Golden Retriever Club or its member; in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

The judging will start promptly. During the hours of judging owners are to be on call and have their dogs ready to bring into the judging ring promptly in order that the judging will not be delayed. Dogs need only be present for the judging of their class. Dogs not needed for further judging may be excused.

Trophies and rosettes must be claimed the day of the show. No trophies will be mailed.

Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. The Judge's measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
